

**Ingersoll Rand's "IQV PowerTRIP" Sweepstakes  
Official Rules  
No Purchase Necessary**

The **IQV PowerTRIP Sweepstakes** ("Sweepstakes") is sponsored by Ingersoll-Rand Company, 800-B Beaty St. Davidson, NC 28036 ("Ingersoll Rand"). By entering, each entrant accepts and agrees to be bound by these Official Rules.

This Sweepstakes is comprised of the following two components: (a) Entering the sweepstakes by completing the entry form on the following website: <http://www.IQVPowerTrip.com>; and (b) random online drawing.

- 1. SWEEPSTAKES PERIOD:** The Sweepstakes begins at 8:00am eastern time on October 7, 2016 and ends at 12:00am eastern time on November 7, 2016 ("Sweepstakes Period"). All entries must be received by 12:00 am eastern time on November 7, 2016. Note: Ingersoll Rand's computer is the official time keeping device for the online random drawing.
  
- 2. ELIGIBILITY:** Participation in the Sweepstakes is open only to legal residents of the 50 United States and District of Columbia who are 21 years of age or older on the date of the Sweepstakes entry submission. - 5. RANDOM SWEEPSTAKES DRAWING:** Ingersoll Rand will conduct a random online drawing within five (5) business days immediately following the expiration of the Sweepstakes Period. Winners will be selected by random online drawing by Ingersoll Rand from all eligible entries received within the Sweepstakes Period. Potential winners will receive a message by e-mail within five (5) business days following the random drawing. **Odds of winning depend upon the number of eligible entries**

**received.** A purchase of Ingersoll Rand's products will not increase the odds of winning.
